- Policy for serving alcohol at events (Beer Gardens) draft motion will be circulated for discussion at next board meeting
- History Project update Michelle and Norm volunteered to proofread History documents SaskSport Hall of Fame reviewed the research, and recommends that we adjust Phase II and III due to the quality of work completed in Phase I. They also recommend that since we have a "permanent" location to use for display (the Cable Park building), it could be the site for banners, business flags, posters and some memorabilia, and the Travel Clinic could have rotating displays that could be set up, and skip the trailer purchase for travelling exhibit in the original proposal from 2022. The banners, flags and memorabilia could easily be transported and set up at events as well. Len will re-do the Phase II proposal based on SaskSport recommendations and submit a new Phase III proposal to the SSHOF by Apr. 1st.

### **New Business:**

### 1. VP Finance – Mike S.

2025 draft budgets – There is increased need for focusing on self-help through fundraising and partnerships, as well as membership growth. Grants will continue to be important for external self-help to maintain programming, especially for Adaptive and the underrepresented portion of our budget. The association will need the Canada Summer Job grant, we applied for 5 positions in 2025, in order to maintain the past program opportunities for Waterski provincial coach and Travel Clinic, as well as adding the Cable Park jobs. Our 2024 budget was dramatically impacted by only have 2 positions covered by the CSJ, and if this continues, hard choices will have to be made regarding the programming. 2 budgets are prepared, one with support from the CSJ, one without support, and the board will have an opportunity to review each at the next meeting once the CSJ is announced.

Len has contacted the auditor for 2024 (Marcia Herback) and will work with Mike S. and Hillary to have the documents prepared and sent.

The board has done their due diligence to present the membership with the Governance review, and has the opportunity to make decisions based on best practice moving forward regarding the board structure. Currently, there are 12 positions with 2 tiers (Executive and Directors), the proposed change had a board of 7 Directors, and has a structure of committee work for certain responsibilities. This will be an agenda for the next full board meeting.
